Medical Care and Treatment of Minor (under the age of 18) Children Consent

Underage Student Housing Policy

It is North Seattle College's policy that all students under the age of 18 live with a homestay family in order to ensure their safety and security while attending classes in the United States. North Seattle College strongly recommends that parents keep their children in a homestay where they can be monitored and cared for until they are 18 years old in the United States, and legally considered adults. In many cases living alone in an apartment or living with older friends may not be an appropriate environment for 16 and 17 year old students.

If parents decide to allow their underage child to live anywhere other than with a homestay family, the parents must complete and submit a Parental Waiver section.
